GROSS DOMESTIC PRODUCT 2019 QUARTER 2

Note: This is the first time that quarterly estimates of Gross Domestic Product (GDP) have been published in Grenada. This series has been developed by the Central Statistics Office (CSO) to provide more timely estimates of the broad trends in economic activity. The series is entirely consistent with the annual estimates of GDP, which still provide the most comprehensive and detailed





assessment of economic activity. The quarterly series is undergoing development and for the time being, should be considered experimental. The CSO would welcome feedback on the utility of this new series.

Summary

In the Second quarter (Q2) of 2019, Gross Domestic Product in constant 2006 prices in Grenada increased by 0.48 percent compared with the same quarter of the previous year 2018. This compares with a decline of 0.92 percent in Q1 2019.

Table: 2 shows that the Grenadian economy have been recording robust economic growth from second Quarter 2013 to fourth Quarter 2018, during this period the economy grew at an average rate of 5.0 percent per quarter. Second Quarter 2019 experienced an increase of 0.48 percent mainly due to an increase in economic activities in the Productive sector 5.68 percent and Private Sector Activities of 1.03 percent.






The growth of 0.48 percent recorded in quarter (Q2) 2019 was mainly attributed to Production Activities 5.7 percent (accounting for 0.4 percentage points towards the total growth), which was derived from the following sub sectors Manufacturing 7.07 percent, Electricity and Water 4.77 percent and Mining 1.86 percent.

Also contributing to the growth was Private Services 1.03 percent (accounting for a further 0.5 percentage points towards the total growth). The following sub-sectors contributed to the growth. Wholesale and Retail Trade 2.06 percent, Hotel and Restaurant 10.29 percent, Transport and Communication 0.92 percent, Financial Intermediation – Banking 0.61 percent, Real Estate Activities 1.00 percent, Private Education 0.77 percent and Private Social Work Activities 1.0 percent.

Despite these increases there was decreases within the mentioned major grouping, Financial Intermediation – Insurance 7.75 percent, Other Business Services 8.75 percent, Private Health 12.07 percent and Private Households with paid employees 1.41 percent.

Construction and Agricultural Activities both contracted by 5.89 percent and 10.20 percent respectively. Contributing negatively towards the growth rate of 0.5 and 0.7 percentage points respectively. The decline in Agricultural Activities was mainly as a result of Agricultural Crops and Livestock of 18.3 percent and 1.72 percent respectively. However these decreases were offset by the above increases.
